- Advisory Member** \$40.00
May be held by any REALTOR® member of the Atlanta Commercial Board of REALTORS® who is 36 years of age and above as of January 1st of each membership year. These members shall neither be able to hold office nor have a vote in Committee affairs, but shall otherwise enjoy all privileges of REALTOR® membership.
- Affiliate Member** \$50.00
May be held by any persons who have an interest in the real estate industry. These members shall neither be able to hold office nor have a vote in Committee affairs, but shall otherwise enjoy all privileges of REALTOR® membership. These members must hold Affiliate or Affiliate Associate membership in the Atlanta Commercial Board of REALTORS®.
